Specifications

All work submitted must be original and completed within the past two years. All media eligible. No saw tooth hangers. 2D work should be matted (neutral color) when appropriate.

Deadline

All entries must be received by **September 22, 2008**. All work must remain on display for the duration of the exhibit.

Entry Guidelines

Artists must hand deliver actual works.

Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$24.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$3.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).

Agreement

FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work. A 25% donation of sale price is required of all sales. By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

He was also an adjunct professor at both Germanna Community College and the University of Mary Washington. He has conducted workshops all over the United States. His exhibitions include showings at Howard University, Washington, D.C., Twentieth Century Gallery, Williamsburg, African American Gallery, Columbia, Maryland, Mt. Sterling Gallery, Kentucky One Man Exhibit, Frejus, France, French Rivera. Johnny holds numerous awards for watercolors and mixed media and holds the Governor's Lifetime Achievement Award in Art in the Fredericksburg area and the James Farmer Memorial Award for Art.
