Submit JPG images (1600 pixels in the longest dimension) on CD or original artwork.

Deadline

September 21, 2012, 4 p.m.

All entries must be received by the deadline. Please allow for any holiday mail delays. All work must remain on display for the duration of the exhibit.

Agreement

- FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work.
- A 25% donation of sale price is required of all sales.
- By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

Eligibility

This exhibition is open to all artists. Please, no work previously juried and accepted in the FCCA Frederick Gallery.

Specifications

- All work submitted must be original and completed within the past two years.
- All media eligible.
- All 2D work must be ready to hang.
- No saw tooth hangers.

Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule.

- \$25.00 for first work, \$5.00 for each additional work entered.
- FCCA members: \$15.00 first work, \$5.00 for each additional.

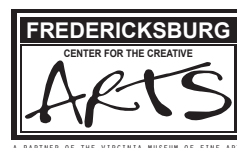

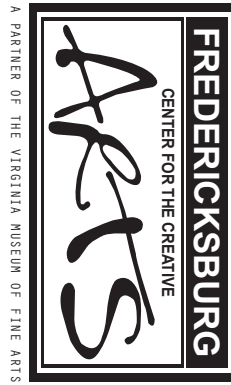

Anne earned a B.A. in Liberal Arts, with a Fine Arts/Painting Major and Communications Studies Minor, from Virginia Polytechnic Institute, Blacksburg, VA and a Masters of Art Education from Virginia Commonwealth University, Richmond, VA. In her free time, Anne continues to pursue her passion for art through painting and encaustic workshops.
