Eligibility

This exhibition is open to all artists. Please, no work previously juried and accepted in the FCCA Frederick Gallery.

Specifications

All work submitted must be original and completed within the past two years. All media eligible. All 2D work must be ready to hang. No saw tooth hangers.

Deadline

All entries must be received by **July 22, 2011**. All work must remain on display for the duration of the exhibit.

Entry Guidelines

Artists must hand deliver actual works. Place submission form(s) and entry fee in an envelope and attach to back of artwork. All work **MUST** be labelled on back with title of exhibit, title of artwork, and artist's name. Sign in all hand-delivered entries at docent desk.

Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$25.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$5.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).

Agreement

FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work. A 25% donation of sale price is required of all sales. By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

Artist Contract

If your artwork was selected for this exhibit, you need to sign and return a copy of the Artist Contract. Pick up contract at FCCA, or download form at www.fccava.org.
